CERTIFIED COMPLAINT

NOW COMES Relator, Lorain County Bar Association Legal Ethics and Grievance Committee, by and through the undersigned Bar Counsel, and alleges that Respondent, Kenneth J. Lewis (Registration No. 0073002), Attorney at Law, duly admitted and in good-standing to practice law in the State of Ohio, is guilty of the misconduct more fully described below.

INTRODUCTION

1. That Respondent, Kenneth J. Lewis (“Respondent”), was admitted to the practice of law in the State of Ohio on November 20, 2000.
2. That Respondent is subject to the Code of Professional Responsibility; The Ohio Rules of Professional Conduct; and, the Ohio Supreme Court Rules for the Government of the Bar.
3. That Respondent has a history of prior discipline imposed against him by the Supreme Court of Ohio.
4. That on April 21, 2009 Respondent was suspended from the practice of law for one year by the Supreme Court of Ohio for forging a judge’s signature on a previously time-stamped judgment entry, in the matter of *Medina Cty. Bar Assn. v. Lewis*, 121 Ohio St.3d 596, 2009-Ohio-1765.
5. That on May 4, 2010 Respondent was reinstated to the practice of law in the State of Ohio.
6. That Respondent’s status as an attorney in the State of Ohio is currently “Active.”
7. That on or about June 10, 2016 Respondent was arrested on the charge of Obstructing Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31, for an incident which occurred on June 9, 2016 wherein Respondent was involved in an alcohol-related traffic accident in Elyria, Ohio and allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

8. That on or about June 20, 2016 LCBA, by and through its Certified Legal Ethics and Grievance Committee (“The Committee”), opened an investigation (“The Investigation”) into the facts and circumstances surrounding the traffic accident along with Respondent’s pending criminal charge in the Elyria Municipal Court and assigned the matter to Attorney James S. Gemelas (“Attorney Gemelas”), a member of The Committee, for investigation.

9. That on or around June 23, 2016 Attorney Gemelas sent Respondent notice of The Investigation and requested that he respond within twenty (20) days from the date of his letter of inquiry.

10. That on or around July 9, 2016 Respondent timely replied.

11. That on July 25, 2016 at a regularly scheduled meeting of The Committee, affirmative votes were recorded finding probable cause that Respondent had committed multiple violations of the Ohio Rules of Professional Conduct and the Ohio Supreme Court Rules for the Government of the Bar.

12. That the matter was assigned to Attorney D. Chris Cook, Bar Counsel to LCBA, for prosecution.

13. That on or around July 26, 2016 Respondent formally agreed to waive probable cause.

14. That on July 27, 2016 a copy of the Certified Complaint was served upon Respondent by Bar Counsel.

FACTUAL ALLEGATIONS

15. Relator incorporates and realleges the allegations contained in paragraphs 1-14 above as if fully rewritten herein.

16. That on or around June 9, 2016 at approximately 1:14 a.m. Officers Merrill and Kasperovich of the Elyria Police Department were detailed to the area of Fourth Street and East Avenue in Elyria, Ohio on a report of a single unit accident.

17. That upon arrival, Officer Kasperovich observed a white female, later identified as Attorney Heather Wilsey ("Wilsey"), and a white male, identified as Respondent, walking westbound on the south side of Fourth Street, away from the traffic accident scene.

18. That Officer Kasperovich stopped Respondent and Wilsey who advised that they were in the vehicle at the time of the accident.

19. That Officer Merrill was on the scene of the accident and observed that a Grey, Acura TL was in the tree lawn on the south side of Fourth Street.

20. That Officer Merrill observed the vehicle to have heavy right side damage from the accident such that the rim and tire were destroyed.

21. That the extent of the damage to the vehicle rendered it non-operable.

22. That Officer Merrill assisted in the traffic investigation and conducted a field interview with Respondent.

23. That Respondent advised Officer Merrill that he and Wilsey were intoxicated at a local bar, the Train Station, when they met an unknown black male who advised that he would drive Respondent and Wilsey home.

24. That Respondent further advised Officer Merrill that he entered the back seat of the vehicle and that Wilsey got into the front passenger seat of the vehicle.

25. That Respondent told Officer Merrill that the unknown black male then entered the driver's seat of the vehicle and pulled out the parking lot to travel southbound on East River Road.

26. That according to Respondent the unknown black male drove to Fourth Street and then turned westbound onto East Avenue at which time he traveled through the intersection and hit a utility pole on the north side of Fourth Street and continued to travel until he hit the left curb on Fourth Street.

27. That Respondent advised that the unknown black male, whom he described as wearing a red ball cap, dark colored shirt and camouflage shorts, ran from the scene in a southbound direction through the parking lot following the accident.

28. That Respondent further advised that at no time were either he or Wilsey driving the vehicle after they left the Train Station with the unknown black male.

29. That Officer Merrill also assisted with the field interview of Wilsey who advised that she never drove the vehicle after it was parked at the Train Station.

30. That Wilsey confirmed Respondent's same description of the suspect driver as a black male that ran southbound through the parking lot following the motor vehicle accident.

31. That Wilsey further advised that she was aware of the suspect and would attempt to get him to return to the scene of the accident but that she was unsuccessful that evening.

32. That Wilsey told the officers she would provide the suspect's name to the officers the next evening after she spoke to her girlfriend and requested that she be permitted to retrieve her cell phone from the vehicle.

33. That Respondent and Wilsey were advised by the officers that they did not believe their version of the events and that the case would be investigated as an open hit-skip accident.

34. That Respondent and Wilsey were advised that they would need to provide a written statement to complete the accident report and that the officers would speak to them at 10:00 p.m. on June 9, 2016 at the Elyria Police Department.

35. That Respondent and Wilsey advised the officers that they would meet them at the police department and attempt to secure the unknown black male and have him come with them to the department.

36. That on June 9, 2016 at approximately 1:45 a.m. Officers VanWormer and Longacre of the Elyria Police Department were detailed to the Train Station to further investigate the accident.

37. That the Train Station maintained a video recording of the parties leaving the bar just prior to the motor vehicle accident.

38. That Officer Merrill met with Officer Longacre and reviewed the video recording.

39. That the video recording revealed that no black male had entered the vehicle but rather Wilsey had driven the vehicle away from the Train Station while she was highly intoxicated.

40. That the video recording further revealed that Respondent was the front-seat passenger in the vehicle.

41. That on June 9, 2016 Officer Merrill was contacted by Respondent who advised that he and Wilsey could not come to the police department at 10:00 p.m. that evening to complete the accident report because he had to watch his children and had no means of getting to the department.

42. That in turn, Officer Merrill advised Respondent to come to the police department on June 10, 2016 at 10:00 p.m.

43. That Respondent agreed that he and Wilsey would come to the police department on June 10, 2016 at 10:00 p.m. to complete the accident report.

44. That on June 10, 2016 at 10:00 p.m. Respondent arrived at the Elyria Police Department alone and advised that Wilsey was not coming in that evening.

45. That Respondent was given a blank OH-3 Traffic Report and provided a written statement.

46. That Officer Merrill reviewed the written statement provided by Respondent and observed that the statement did not honestly and accurately describe the facts surrounding the accident investigation.

47. That as a result, Respondent was arrested on the charge of Obstruction of Official Business, in violation of R.C. 2921.31.

48. That on June 14, 2016 Wilsey was served with an arrest warrant on the charge of Obstruction of Official Business, in violation of R.C. 2921.31.

COUNT ONE

(ORPC 8.4(b) – MISCONDUCT: ILLEGAL ACT THAT REFLECTS ADVERSELY ON LAWYER’S HONESTY OR TRUSTWORTHINESS)

49. Relator incorporates and realleges the allegations contained in paragraphs 1-48 above as if fully rewritten herein.

50. That on or about June 10, 2016 Respondent was arrested on the charge of Obstruction of Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31.

51. That all as described above, the charge against Respondent stems from his involvement in an alcohol-related traffic accident in Elyria, Ohio wherein Respondent allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

52. That Respondent allegedly provided false and misleading information to law enforcement officers regarding an “unknown black male driver” during the investigation of the motor vehicle accident in which he was admittedly involved.

53. That to impede and obstruct an official police investigation by providing false and misleading information to law enforcement personnel constitutes an *illegal* act that reflects adversely on Respondent’s honesty or trustworthiness.

54. That Respondent’s commission of an *illegal* act that reflects adversely on his honesty or trustworthiness constitutes a violation of ORPC 8.4(b).

COUNT TWO

(ORPC 8.4(c) – MISCONDUCT: DISHONESTY, FRAUD, DECEIT OR MISREPRESENTATION)

55. Relator incorporates and realleges the allegations contained in paragraphs 1-54 above as if fully rewritten herein.

56. That on or about June 10, 2016 Respondent was arrested on the charge of Obstruction of Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31.

57. That all as described above, the charge against Respondent stems from his involvement in an alcohol-related traffic accident in Elyria, Ohio wherein Respondent allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

58. That during his field interview with Officer Merrill, Respondent affirmatively represented to Officer Merrill that he and Wilsey were intoxicated at a local bar, the Train Station, when they met an unknown black male who advised that he would drive Respondent and Wilsey home.

59. That Respondent further affirmatively represented to Officer Merrill that neither he nor Wilsey ever drove the vehicle which was involved in the motor vehicle accident and that he entered the back seat of the vehicle while Wilsey got into the front passenger seat of the vehicle which was then driven by an unknown black male who caused the motor vehicle accident.

60. That Respondent provided a false and misleading description of an unknown black male driver as wearing a red ball cap, dark colored shirt and camouflage shorts that ran from the scene in a southbound direction through the parking lot following the motor vehicle accident.

61. That in addition to the above, Respondent provided a false and misleading written statement to law enforcement personnel which did not honestly and accurately describe the facts and circumstances surrounding the accident investigation.

62. That Respondent's verbal representations to Officer Merrill and his written statements were dishonest, fraudulent and deceitful as the video-recording obtained from the Train Station revealed that, in fact, no black male had entered the vehicle but rather Wilsey herself had driven the vehicle away from the Train Station while she was highly intoxicated.

63. That by fraudulently misrepresenting the details of the motor vehicle accident to Officer Merrill and by providing a false and misleading written statement in the ensuing traffic investigation, Respondent engaged in conduct that constitutes a violation of ORPC 8.4(c).

COUNT THREE
(ORPC 8.4(d) – *MISCONDUCT: PREJUDICIAL TO THE ADMINISTRATION OF JUSTICE*)

64. Relator incorporates and realleges the allegations contained in paragraphs 1-63 above as if fully rewritten herein.

65. That on or about June 10, 2016 Respondent was arrested on the charge of Obstruction of Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31.

66. That all as described above, the charge against Respondent stems from his involvement in an alcohol-related traffic accident in Elyria, Ohio wherein Respondent allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

67. That Respondent allegedly provided false and misleading information to law enforcement officers regarding an "unknown black male driver" during the investigation of the motor vehicle accident in which he was admittedly involved.

68. That Respondent affirmatively represented to the officers that neither he nor Wilsey ever drove the vehicle involved in the accident at issue after it was parked at the Train Station.

69. That Respondent further affirmatively represented to Officer Merrill that the suspect driver of the vehicle was an unknown black male who ran southbound through the parking lot after causing the motor vehicle accident.

70. That Respondent's representations to Officer Merrill were dishonest, fraudulent and deceitful as the video-recording obtained from the Train Station revealed that, in fact, no black male had entered the vehicle but rather Wilsey herself had driven the vehicle away from the Train Station while she was highly intoxicated.

71. That as a result, Respondent impeded and obstructed an official police investigation by providing false and misleading information to law enforcement personnel.

72. That, all as alleged above, law enforcement personnel was harmed through the loss of time and resources by processing and investigating false allegations provided by Respondent in an effort to impede and obstruct an official police investigation.

73. That Respondent's misconduct in impeding and obstructing an official police investigation constitutes a violation of ORPC 8.4(d).

COUNT FOUR

*(ORPC 8.4(g) – MISCONDUCT: CONDUCT INVOLVING DISCRIMINATION
PROHIBITED BY LAW BECAUSE OF RACE)*

74. Relator incorporates and realleges the allegations contained in paragraphs 1-73 above as if fully rewritten herein.

75. That on or about June 10, 2016 Respondent was arrested on the charge of Obstruction of Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31.

76. That all as described above, the charge against Respondent stems from his involvement in an alcohol-related traffic accident in Elyria, Ohio wherein Respondent allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

77. That Respondent allegedly provided false and misleading information to law enforcement officers regarding an “unknown black male driver” during the investigation of the motor vehicle accident in which he was admittedly involved.

78. That Respondent affirmatively represented to the officers that neither he nor Wilsey ever drove the vehicle involved in the accident at issue after it was parked at the Train Station.

79. That the video-recording obtained from the Train Station revealed that, in fact, no black male had entered the vehicle but rather Wilsey herself had driven the vehicle away from the Train Station while she was highly intoxicated.

80. That Respondent’s false and misleading representations to Officer Merrill in an official law enforcement investigation that the suspect was a black male who caused the accident in which Wilsey was the actual driver constitutes conduct involving discrimination prohibited by law because of race by a lawyer in his professional capacity and is a violation of ORPC 8.4(g).

COUNT FIVE
(ORPC 8.4(h) – *MISCONDUCT: ADVERSELY REFLECTS ON THE LAWYER'S FITNESS TO PRACTICE LAW*)

81. Relator incorporates and realleges the allegations contained in paragraphs 1-80 above as if fully rewritten herein.

82. That on or about June 10, 2016 Respondent was arrested on the charge of Obstruction of Official Business, a misdemeanor of the second degree, in violation of R.C. 2921.31.

83. That all as described above, the charge against Respondent stems from his involvement in an alcohol-related traffic accident in Elyria, Ohio wherein Respondent allegedly gave a false police report to law enforcement officers in an effort to avoid a potential OVI arrest.

84. That Respondent allegedly provided false and misleading information to law enforcement officers regarding an “unknown driver” during the investigation of the motor vehicle accident in which he was admittedly involved.

85. That Respondent affirmatively represented that neither he nor Wilsey ever drove the vehicle involved in the accident at issue after it was parked at the Train Station.

86. That Respondent further affirmatively represented to Officer Merrill that the suspect driver of the vehicle was an unknown black male who ran southbound through the parking lot after the accident.

87. That Respondent’s representations to Officer Merrill were dishonest, fraudulent and deceitful as the video-recording obtained from the Train Station revealed that, in fact, no black male had entered the vehicle but rather Wilsey herself had driven the vehicle away from the Train Station while she was highly intoxicated.


88. That as a result, Respondent impeded and obstructed an official police investigation by providing false and misleading information to law enforcement personnel.

89. That based on the dishonest, deceptive, and unlawful nature of Respondent's misconduct and the potential that Respondent's misconduct implicates substance abuse issues, Respondent has engaged in conduct that adversely reflects on his fitness to practice law and constitutes a violation of ORPC 8.4(h).

WHEREFORE, pursuant to Gov. Bar R. V, Relator alleges that Respondent, Attorney Kenneth J. Lewis, has violated the Ohio Rules of Professional Conduct and the Ohio Rules for the Government of the Bar.

As such, Relator respectfully requests that the Board proceed accordingly; certify this matter for prosecution; and allow this matter to progress forthwith.






