SHINING STARS COMPLETE SUBSTANCE ABUSE PROGRAM

Laura L. Vaughn was ready to give up. A mother of five and grandmother of five more, she had no idea what to do about her middle child, LaKisha N. Bristow, a pretty girl who was out of control. Though just a teenager, LaKisha had a delinquency record that stretched six years, with charges ranging from obstruction and robbery, expulsion from school, drinking alcohol and smoking marijuana. Her behavior landed her in a girl's group home.

13 CUYAHOGA COUNTY JAIL INMATES DIED IN 7 YEARS, ACCORDING TO REPORT

Thirteen inmates died in the Cuyahoga County Jail between 2000 and 2007. They were among 8,110 deaths of inmates in local jails nationwide in that seven-year period, according to a report from the federal Bureau of Justice Statistics released today. The number of deaths has increased each year since 2000, but the death rate per 100,000 inmates actually fell because of the increase in the jail population. The number of deaths went from 905 to 1,103, during the period studied. The total inmate population increased 31 percent – from 597,226 to 782,592, according to the report. [More...](#)

UNJUST RULING

For years, the laws governing sentencing for crack and powder cocaine possession were out of sync with fundamental notions of fairness. The crack epidemic of the late 1980s and early 1990s put pressure on lawmakers to treat one form of cocaine as inherently more toxic than another. OCJS AND OHIO PRESCRIPTION DRUG GRANT

Deadline: July 12, 2010

The focus of this grant is to target organized illegal prescription drug cases that involve source targets. Generally, source targets are those responsible for knowingly making the abuse possible by supplying users through illegal or unlawful means as defined by state and federal law. Proposed to defray the expenses incurred during a prescription drug investigation related to illegal prescription drug abuse, the Ohio Prescription Drug Grant provides agencies with funding to investigate and prosecute these types of cases. The solicitation release date will be **June 11** and proposals will be due by **July 12**. Award notifications of funding will be released on **August 30**. Agencies may apply for a maximum of \$15,000 in federal funds to investigate and prosecute substantiated prescription drug cases. No match is required for this grant program. However, the applicant should be able to show the agency's vested interest by supplying personnel, equipment, etc. to supplement the investigation.

The National Institute of Mental Health (NIMH), National Institute on Alcohol Abuse and Alcoholism (NIAAA), and the National Institute on Drug Abuse (NIDA) will fund research that will reduce the burden of suicidality (deaths, attempts, and ideation). Funding is intended to intensify investigator-initiated research on the topic, attract new investigators to the field, and increase interdisciplinary approaches to developing effective strategies to reduce suicidality. Mental disorders, along with alcohol use disorders (AUDs) and substance use disorders (SUDs), are of particular interest as they pertain to risk and protective factors and treatment efficacy and effectiveness for suicidality. Eligible applicants include public and private universities, nonprofits, for-profits, and state governments. The number and amount of grants to be awarded are contingent upon the availability of funds and the submission of a sufficient number of meritorious applications. Applications must be submitted electronically, and applicants must register at least four weeks before the grant submission

SAFETY NET DENTAL CARE PROGRAMS IN OHIO

Safety Net Dental Care Programs provide clinical dental services and generally are operated by local health departments, community health centers, hospitals and other organizations that serve the community. Ohio has approximately 100 programs that provide basic dental services and 12 programs that offer preventive care. These programs offer sliding fee schedules, reduced fees or free care to clients who typically can't afford to pay a private dentist. REPORT PROVIDES DATA AND TRENDS IN JUVENILE COURT CASES

The National Center for Juvenile Justice has published "[Juvenile Court Statistics, 2006-2007](#)," which was developed with funding from the Office of Juvenile Justice and Delinquency Prevention. Drawing on data from the National Juvenile Court Data Archive, the report profiles the nearly 1.7 million delinquency cases handled each year by U.S. courts with juvenile jurisdiction in 2006 and 2007. It also describes trends in delinquency cases processed by juvenile courts between 1985 and 2007 and status offense cases handled between 1995 and 2007.
